## OUR LIBRARY

The library is the 'heart' of any academic institution and plays an important role in all academic activities and more so in law institutions. The college library serves as the intellectual foundation for the students and faculty engaged in legal education and research. The library collection includes a comprehensive array of legal resources in both print and electronic forms as well as access to online law resources. The library is dedicated to provide expert services to the student community with legal research guidance and to look forward to assist students and researchers for their legal research.

The library is located at second floor of the college building with a large number of seating capacity. Library is automated and circulation of books is maintained with the help of barcode system. The library is automated using library module of VRIDDHI Software integrated campus management software). VRIDDHI Software integrates all the libraries through Intranet in Azam Campus and the OPAC of all the campus libraries can be searched at one terminal. Library has CCTV system to monitor activities of students and other patrons towards security and safety issue.

### BOOKS

The collection comprises over 7000 documents including encyclopaedias, commentaries, reference books, text books on various subjects like Jurisprudence and Legal Theory, Clinical and Legal Education, Legal Research, Professional Ethics, Law and Society, Family Law, International Law and Human Rights, Constitutional Law, Administrative Law, Cyber Law, Labour Law, Medical Law, Biotechnology Law, Environmental Law, Criminal Law, Law of Contracts, Torts, Property Laws, Land Laws, Company Law, Banking Law, Judicial Process, Judicial Activism, Arbitration and Conciliation, Interpretation of Statutes and so on. In non-law section, library has books of Economics, Sociology, Political Science, English, Legal Language and History.

## REFERENCE RESOURCES

The collection includes handbooks, general and legal dictionaries, legal encyclopaedias like Halsbury's Laws of England, Halsbury's Laws of India, Manuals, Digests, and Index to Indian legal periodicals and other reference books.

## LAW REPORTS

The College also subscribes a number of reports like All England Law Reports, All India Reporters, AIR Civil Cases, AIR Law Lines, Arbitration Law Reporter, Accidents Claims Journal, Supreme Court Case, Company Cases, Income Tax Reports, Maharashtra Law Journal, Labour Law Journal, Criminal Law Journal, Consumer Protection Judgments, Corporate Law Adviser, Patent and Trade Marks Cases, Divorce and Matrimonial Cases etc.

## LIBRARY SERVICES & FACILITIES

### A) ON LINE PUBLIC ACCESS CATALOGUE (OPAC)

Library has OPAC of its holdings and users can search database of books and journals through Title, Author, Subject, etc. OPAC also helps the users to search database of other college libraries in Azam Campus and the status of Books and other documents.

## B) DIGITAL LIBRARY

Digital Library collection comprises 20000 text books of all subjects, syllabi, question papers etc. The students can read books of various streams from any college in the campus according to their interest and requirement.

## C) CIRCULATION (ISSUE/RETURN OF BOOKS)

Students may borrow books for home for 8 days as per details given below:

B.A. LL.B, I& II Year: 2 Books at a time of their syllabus and one general book.

LL.B. & B.A. LL.B. (III Year onwards): 3 Books at a time.

LL. M. – 4 Books at a time.

## D) ON DEMAND FACILITY

The Library provides both anticipatory and on-demand services for better utilization of information resources with maximum satisfaction of students and faculty. Reference and general queries from users are answered personally by the library staff. Newspaper clippings, display of new arrivals, display of notices and other useful information are main activities under Current Awareness Services. The library also organises books exhibition.

## E) PHOTOCOPIER FACILITY

Library provides photocopy and printouts service to the students at nominal charges.

## F) INTER-LIBRARY BORROW-UP FACILITY

Library has an inter-library loan arrangement with all the college libraries in Azam Campus.

## G) ON-LINE DATABASES

Library provides access to over 6,000 e-journals and 97,000 e-books of all subjects through N-LIST of INFLIBNET (UGC) and also has IP based access to SCC Online and Manupatra to search database of Judgments of the Supreme Court, High Courts and other related legal resources. The library also has AIR Supreme Court Database 1950-2013 and CD of the Journal of the Indian Law Institute (1958 – 2011).

#### H) LIBRARY ORIENTATION PROGRAMME

At the beginning of every academic year, an orientation programme is organized in the Library for new students. Orientation programme includes library tour, familiarity with online resources, OPAC, reference and allied tools useful for legal research. Students are guided by the library staff to be familiar with the collection and its location within the library.

#### I) READING ROOM AND REFERENCE SECTION

Library has an excellent reading room with 112 comfortable chairs and tables with divider and a separate reference section with seating capacity of 28. The reading room remains open from 9 a.m. to 8.00 p.m. There are 2 reading rooms separate for boys and girls which are common for all the students of Azam Campus and remain open till late night.

#### J) LIBRARY MEMBERSHIP

All the Library facilities are provided to the Library Members only and Library Membership is given on payment of refundable deposit of Rs.500/-. This deposit continues for the entire course and will be refunded to the students after the completion of the full course.

#### COMPUTER INTERNET ROOM

In an era of technology and globalization, education should be at par with the international standards to make the future of students bright. Taking into consideration the importance of the use of the technology into academics, A. K. K. New Law Academy provides a full-fledged air conditioned Computer Room for its students. All the Computers are connected to the internet.

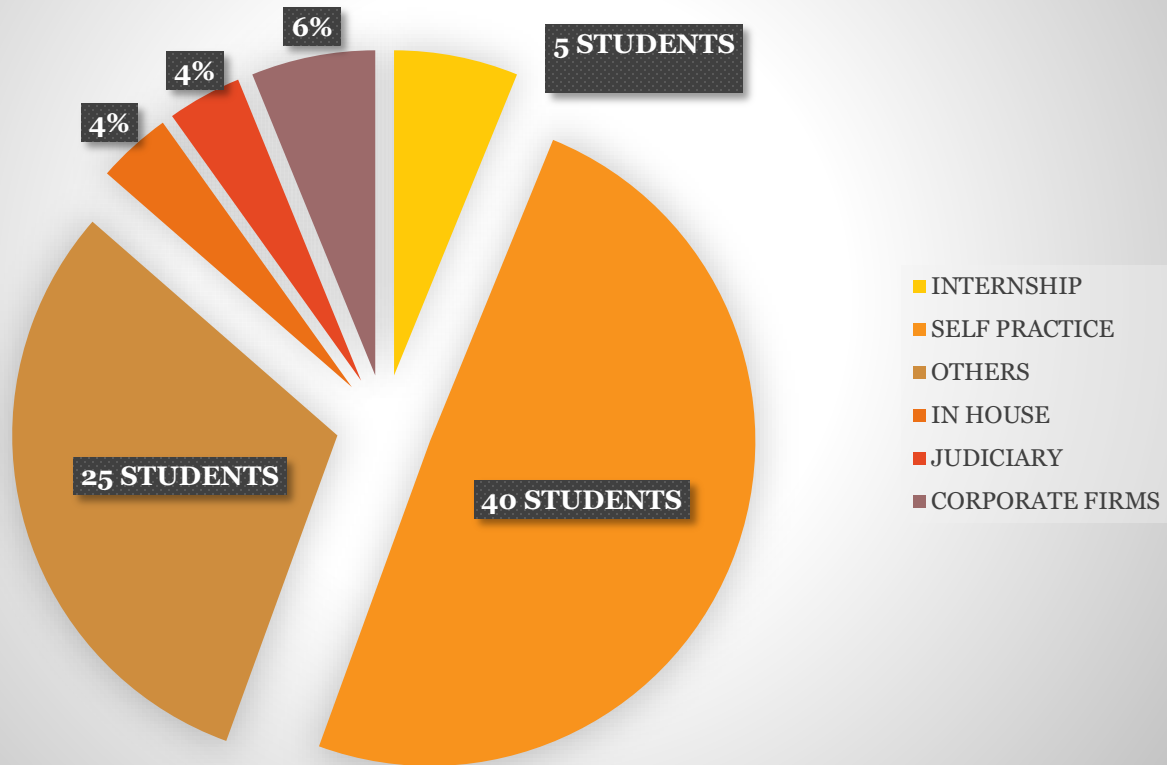




