Feedback Report - 2020-2021

As per the guidelines of NAAC, feedback is taken from the students, alumni and teachers of the college at the end of every academic year to understand and analyse the effectiveness of curriculum delivery, teaching learning and overall performance of the college.

Feedback of the faculty from students and alumni is the measure adopted by the college for ascertaining the subject knowledge and quality of teaching and most importantly for understanding the remedial measures required to be adopted for improving the learning process of students. Feedback about the various academic, co-curricular and other activities in the college is also collected from the students and Alumni of the college.

Students provide this feedback for various aspects such as syllabus of each course, difficulty level of the course programme, library material and facilities for the course, preparation of the teacher for the classes, subject knowledge of the teacher, communicative competence of the teacher, command on language, teacher's approach with the students, academic counseling and assistance from the non teaching staff.

Analysis of the feedback from the students:

All the classes were conducted online due to Covid-19 pandemic. The feedback form was also provided to students online. As far as the nature of syllabus of each class is concerned, the students expressed their reaction regarding the syllabus and it indicates that the syllabi are adequate and manageable for them. In the question related to the syllabus covered in the class, most of the students mentioned that 85 to 100 % syllabus was covered in each subject. Few students reported that 70 to 85 % syllabus was covered. Some students at remote areas found online classes difficult due to lack of basic infrastructure. The teachers provided them notes through Google Classroom. Moreover, in the question related to the library material in the institution, some students mentioned that they found it difficult to get the material and suggested to subscribe online websites to get the relevant material. Hence, the students were provided access to study material through the website of the college library www.nlalibrary.weebly.com.

Furthermore, the library services were extended to the students by making WhatsApp groups and providing online access to the library resources/ open educational resources. In the questions related to preparation of the teacher for the classes, subject knowledge, command on language, communicative competence of the teacher along with teacher's approach towards the students, the majority of the students are satisfied about the well preparedness and communication skills of the teachers. The students' feedback on the questions related to methods of teaching shows that the teachers generally choose the participatory teaching method, through which teachers keep the students active and students are encouraged to raise questions and take part in discussion in regular classes. It is observed that the teachers are helpful in academic counseling and providing support to students time to time.

The students are satisfied with the overall assistance received from the non-teaching or administrative staff of the college. The last question was about the infrastructure provided by the college in terms of sports, canteen, hostel and computer laboratory. As regards the feedback on these facilities provided by the college, very few students made comments about it. Some students suggested to increase the use of technology to enhance the quality of teaching.

Analysis of the feedback from the Alumni:

The feedback forms are collected from the Alumni every year. Alumni give their feedback on various aspects such as admission procedure, educational environment in the college, teaching quality, infrastructure, library, hostel, co-curricular and extra-curricular activities and overall rating of the institution. They are also asked to express their views regarding academic initiatives taken and extension activities organized by the college. Most of the alumni expressed the admission procedure, teaching quality, library excellent. Some students suggested to organize more extracurricular activities. The alumni expressed their satisfaction with the academic initiative taken by the college.

Analysis of the feedback from the Teachers:

In the feedback form of the teachers, they were asked for their opinion about the syllabus of the courses, infrastructure of the college, library facilities and availability of the books and other
