Dr. Rasheed Shaikh, Principal, A K K New Law Academy inaugurated the function and in the Valedictory function he thanked all the experts who coached the centre.





13th September, 2021






Webinar on Legal Education in India




The winner of the tournament was Modern College of Arts, Science and Commerce, Pune and the Runner-up was AbedaInamdar Senior College, Pune.





